ARCHIVES COMMITTEE REPORT: ONTARIO, CANADA

We have a good start on A.A. history in Ontario. Bob D. has agreed to be historian: we are starting to get tapes from older members. Because this information is vanishing it's important to get it now.

It appears that individuals have begun small, localized collections. But no extensive cooperative undertakings have been made: significant reservations have been expressed by people who have documents and historical relics about releasing their collections unless they will be placed in reliable and protected accomodations...

In 1981 a small committee of members with long periods of sobriety was put together. Meetings have been taking place, and the project is being enthusiastically worked on by all those involved. It was the idea of our committee to establish an archives repository for Ontario. A number of localities here had already indicated to G.S.O. that they had commenced to collect historical data and memorabilia.

The group chose Toronto as the geographical location (for an archives) because (1) the greatest number of members would get an opportunity to see the material. (2) Toronto Intergroup Office has the space to display it and is prepared to provide the space. (3) The space is a dry room on the main floor; large

enough to contain at least 3 large display cabinets. (4) The material could be moved readily and put on display at the Ont. Regional Conf.

This choice was supported by the Ont. Provincial Comm. A motion was made and approved unanimously by the Archives Comm. that a recommendation be forwarded to Intergroup and Ont. Provincial Comm. that 3 cabinets, suitable to space available and approval of the Archives Comm. be purchased. The maximum cost to be considered is \$3,000 and it is also recommended that estimates be obtained to get the best prices. Funds required will be from the Toronto Intergroup and the Ont. Provincial Committee.

It will be necessary to follow up members all over the Province to obtain information and material for the project.

Whit H. has offered his personal collection to the Archives. Tom H., chairman

What was discussed was the frequent turnover of archivists in some areas. 
The meeting broke for a beautiful lunch served under a large, colorful tent, set up near the house. Afterwards, the program was resumed and more memories shared.

ARCHIVES EXHIBIT AT OHIO STATE CONVENTION

The 750 attenders at the Conference were treated to a huge room $(36' \times 50')$ of Archival displays. Northwest Ohio Archivist, Mel B., headed a committee that "got it together" for a budget of \$300. Since it's permanent, the plan is to use it again each year with some changes. Mel shared some tips 1) Keep it simple. Local stores have attractive, low-cost, long lasting boards., 2) Blow up pictures so they can be seen 3) double-face tape is a must 4) Don't underestimate interest in material, especially about the younger members, and 5) Safeguard anonymity of members. The "mix" of materials included both general A.A. history; Saturday Evening Post, Liberty Magazine articles and local A. A. milestones in the area. The latter, of course, abound in Ohio.









NEWS AROUND THE ARCHIVES

- DISTRICT OF COLUMBIA: "We have begun the WAIA Washington Area Alcoholics Anonymous Archives project amidst great enthusiasm. As time passes, what we do here today will be history for the alcoholics as yet unborn and so it is important that we not only collect the history of the early years, but that we keep accurate records of what we do today." (Washington Area Intergroup Association New Reporter)
- FLORIDA: "We felt it is necessary to buy a cabinet at the earliest date in order to have a safe place to store the 'goodies' people are willing to donate to our collection. We hope in the future to have a small display cabinet, also. As soon as we have secured a cabinet, we hope to go to any group who would like to see the historical movie, 'Markings on the Journey.' This could stimulate interest in our committee."

- INDIANA: "Progress of Archives to date: We have reached a point in this matter where we really can't go on much further until we locate a place to store the archives. One such place being considered was a Central Office somewhere in the state, hopefully Indianapolis." (Minutes: Indiana State Committee meeting)
- MISSOURI: "The Archives are getting a lot of new items. Mail Bob copies of your group files, district minutes or anything else to do with A.A. today, 'Today's news is tomorrow's history.' They had the same problems in the past that we have now, it might help to read to see how they solved them. . ." (Archives Committee Report -- chairman Bob R., Western Area of Missouri Assembly)
- NEBRASKA: Don B. reported that the Archives display at the State Reunion was well received. He has been asked by the delegate to report on the Archives to the State at some future time. (Minutes of District Twenty Committee meeting Bellvue, Nebraska)
- NEW ZEALAND: "Tom P. has been making steady progress with the Archives but still needs your assistance by letting him have any information you can about your group: When did your group start, who were the original members, where they met, have you hosted any Assemblies...Any information of this nature is important." (New Zealand General Service Conference of A.A. Newsletter)
- SOUTH AFRICA: "Apart from the acquisition of some exciting material this year, the Archives have made little or no progress. This is due to what seems to be the inevitable lack of funds. Val D. is to be thanked for entrusting his valuable books -- gifts from and inscribed and signed by Bill W. -- to the Fellowship Archives."

- VIRGINIA: "I think cooperation between Intergroup and Archives would make a good topic in 'Markings.' I have been in touch with some of our Virginia Intergroups and have mostly gotten good cooperation. Northern Virginia Intergroup has been particularly helpful, allowing me to use their xerox machine to copy various documents for the Archives."
