Would Your Group Help Another?

"I'm sure if two sick alcoholics in Ireland wanted A.A. help and wrote my Group, we'd write them regularly and do all we could to help," said one Delegate to the 1966 General Service Conference.

Another member, who works a lot with A.A.'s in a state prison, said he was sure many prison members would love to write alcoholics overseas to 12-Step them by mail.

As A.A. grows more and more in many corners of the world, more and more newcomers need help in staying sober and getting a Group going. Would your Group be willing to help them?

Here's the idea. Get your Group's G.S.R. to write G.S.O. and tell us that your Group wants to help a lonely, faraway new Group. G.S.O. will then put you in touch with a Group that wants to make friends by mail, and from then on it is up to your imagination.

Maybe you will exchange tapes with

each other. Maybe you'll hold round-robin discussions of the Steps and discussions by letter.

It can be some of the most thrilling 12th-Step work you'll ever do -- to know you are helping and being helped by brother and sister alcoholics in a remote comer of the world. This round-the world sharing of experience, strength and hope is one way to make sure no alcoholic, anywhere, ever feels alone again---if we really mean it when we say, "I am responsible."

Here are some samples of the kind of correspondence you may have:

FROM IRELAND... OR PHILADELPHIA?

"In 1946 Conor F., A.A. member from Philadelphia, was visiting the land of his birth, Ireland. He read in a Dublin paper an interview with Father Tom D., an Australian priest who said he thought Dublin could use some A.A.

"Conor went to the 'hospital for the deranged' that Dean Jonathan Swift of England had founded in exile 201 years earlier, and talked to alcoholics there. . . in six months, there were 8 or 10 sober, and A.A. was started in Europe.

"It's not really Irish, of course, William

Groups in five North American regions can begin now choosing A.A. members to be elected Regional Trustees of the General Service Board in 1967.

Nominations -- roughly one from each state or province in the electing areas -- should be received at G.S.O. no later than Jan. 15, 1967. Final selections will be made at the April G.S. Conference meeting in New York.

Regions involved are:

- Canada East (Ont., Que., Nova Scotia/Nfld. and N.B./P.E.I.) -- created to conform with the Board re-structure plan adopted by the 16th Conference. (Canada West is currently filled by Tom B., of Winnipeg.)
 - East Central U.S.A. (III., Ind., Mich., Ohio) -- to replace Bruce M., Ohio, completing his 4-yr. term in '67.
 - Pacific U.S.A. (Alaska, Ariz., Calif., Hawaii, Idaho, Nev., Ore., Wash.) --to succeed Jim M., Calif., whose term expires in '67.
 - Southeast U.S.A. (Ala., Fla., Ga., Ky., La., Miss., N.C., Puerto Rico, S.C., Tenn., Va., W. Va.) -- no trustee since 1965, because of rotation.
 - Southwest U.S.A. (Ark., Colo., Kans., N. Mex., Okla., Tex., Utah) --- no trustee since '65.

(All Conference Delegates and Area Committee Members in the electing regions have received notification of the election (if G.S.O. has your correct mailing address) with letters explaining the procedures set up by the Conference in 1962-63 Regional Trustee elections.)

A.A. trustees normally serve 4-year terms, and in the past regions have rotated their turns to name a Regional Trustee.

Under the new Board structure, however, none of the six U. S. and two Canadian regions will be without such a trustee in the future.

It is by now a well-established fact that Regional Trustees when elected do not "represent" sectional A.A. interests,

IDEA FOR GROUPS

Groups—especially those in small towns—that wonder how to let alcoholics know there is a local A.A. Group, and how to find it, might try this:

Take a small card or sheet of paper, print on it the name of the Group and its meeting place and time, and a telephone contact. Then be sure to deliver one of the notices to (1) every police station, jail, etc., (2) every hospital or clinic, (3) every doctor, (4) every clergyman, (5) every church, (6) every social, health, or welfare agency, and (7) every large firm.

In larger urban areas, the whole meeting list could be distributed along with the Central Office address and telephone number. Probably you'll also want to take along an appropriate A.A. pamphlet ("A.A. in your Community"), or the

what happens at G.S.O. in New York. Since Groups in Canada and the U.S.A. discussed Conference agenda topics *before* the Conference, no doubt Groups would like to learn what was the "consensus" of the Fellowship's feelings on such matters as the Preamble wording, the nonalcoholic trustees, institutions etc.

FINAL CONFERENCE REPORT was mailed out July 18; you can get the complete volume for \$1.50 (much bigger and different from previous ones). Each Group should have one, to keep well-informed about A.A.-as-a-whole.

4. Would your Group like to see a different "Discussion Topic" suggested in each issue of the *Exchange Bulletin?* Some Delegates said Groups would like subjects suggested for meetings. Let us know what you think of this.

5. NEWS BULLETIN: have you noticed that the Conference this year decided for the first time that G.S.O. can accept a bequest of not more than \$100 from an A.A. member?

6. NOTICE: World Directory is exclusively for A.A. use, Conference said again this year. If any other agency or organization, or a non-member, wants a copy, get in touch with your Delegate.

James, the great philosopher whose book VARIETIES OF RELIGIOUS EXPERI-ENCE so influenced Bill W. and led to the 12 Steps, was American-and delivered his lectures in Edinburgh, Scotland. And if it hadn't been for the Aussie padre ... Well, you see A.A. has no boundaries."

FROM AUSTRALIA... OR HUNGARY?

"Alex died at 48 in October, 1965, just before his third sober Christmas. He had joined A.A. in Sydney, and devoted his life to it after we moved to Victoria. He was a lawyer.

"When he heard his mother was ill in Hungary he went to see her. He told his best childhood friend, now a famous radiologist, about his alconolism and his recovery in A.A. As a result, the Hungarian government's 'Commission Against Alcoholism' had him speak.

"The Commission printed an article about A.A. in its magazine, and gave the Sydney, Australia, Central Office address.

"Now a fellow named Tibor J., presently in a sanitarium in Hungary, wants help in starting a Group. Who will help?"

INTERNATIONAL COMMITTEE

That's the kind of letter we get all the time at G.S.O., and our International Committee advises us on helping "anyone, anywhere, who reaches out for help--so the hand of A.A. can always be there."

We have a translation committee nowlooking into new translations of A.A. material into Japanese and Dutch. (A Texas Group recently pointed out that one of our Spanish translations incorrectly uses the word cure.) A new French book on alcoholism talks a lot about

A.A., but doesn't mention there are 17 Groups in France. We're trying to remedy that.

FROM YUGOSLAVIA

A request for help from Belgrade arrived here just about the time one of our Internationalists is arriving there. We've sent him literature in Polish and Hungarian, and will have the Steps translated into Slovene.

In Colombia, the Literature Distribution Center is functioning fine, according to reports we get. . . Twelve sober members in Vitoria, Spain, have held several public meetings and find there is much interest. . . . We now put out a regular 'Boletin' in Spanish, and hope soon to have A.A. talks taped in Spanish. . . . Australia is setting up its own A.A. service council and publishing office.... Over 200 attended a big German-speaking A.A. conference in Frankfurt-Main in April. Ken W. and Eve M. of the U.S.A. were there. (All delegates were called "Trusted Persons.")....Don R., just returned from Central America. He visited Groups in Guatemala (450 people per meeting!), where everyone sober is allowed to speak if he wishes!....He was also enthusiastic about meetings he went to in El Salvador, Honduras, and a prison in Costa Rica. He visited a Loner in Nicaragua, and tells us there are now about six regular members who have been attending Spanish-speaking meetings in Panama the last six months.

Does any A.A. really not want to be sharing all these exciting new A.A. developments? Please let us know how your Group feels.

WE ALSO NEED NEVER DRINK'

The above is printed on the letterhead of the Koala Group. Here's why:

"We get quite a few people asking how we came to pick the koala bear for our Group mascot. The koala NEVER drinks. He gets all his liquid needs from the juice of the gum leaves he nibbles.

"Not that we tear around chewing gum leaves, we just cut out the booze part of our drinking habits.

any more than Conference Delegates do; instead, their focus is on serving the entire A.A. worldwide Fellowship as a whole.

Suggested Procedures

In the letter calling for trustee nominations, Gene K., chairman of Trustees' Nominating Committee, emphasized the following suggested procedures recommended by the Conference:

(a) Delegates and G.S. Committee Members should decide how the state or province will select its candidate, whether the Area Committee wishes to choose him, or to take the matter to G.S.R.'s through Area Assemblies — and if so, where and when.

(b) Third Legacy procedures, particularly written ballots, 2/3 vote or the drawing by lot if voting fails, should be used whether selection is by G.S. Committees or by Assemblies.

(c) Delegates or Chairmen of Area Committees should send to G.S.O. complete reports of all procedures decided upon.

(d) They should also send a biography of each candidate, covering professional and A.A. service experience, plus name and address of the candidate, to G.S.O. before Jan. 15, 1967.

(e) Final selection from among state and provincial candidates will be made at a joint meeting of the G.S. Conference Trustee Committee, the Nominating Committee of the Board, and Delegates from the regions affected, held during the April 1967 Conference.

THIRD LEGACY MANUAL procedure of election will be followed in making the final choice.

(f) Chosen candidate will then be offered to the Conference for approval, and election to the Board will follow.

(g) Qualifications: A sound A.A. background is a basic requirement. Ten years of sobriety is recommended but is not mandatory. The candidate should have been active in A.A. affairs, locally and regionally. He should have the background and willingness to make decisions on matters of movement-wide policy, both internally and externally.

(h) Business or professional experience: It has proved desirable to have some of the trustees of very high competence in business and professional matters— because the primary business of the Board calls for important budgetary and administrative decisions. For example, a banking executive, an executive of the press or broadcast media, a lawyer with experience, an industrial executive --- such qualifications are regarded as welcome additions to sound A.A. experience.

(i) Time required: Quarterly meetings of the Board in January, July, and October take at least three days each. The April meeting and the Conference add up to a week. Trustees are reimbursed for travel and hotel expenses.

ABOUT REGISTERING A GROUP...

"The Group has asked me to write for all details, forms, and other information necessary for having our Group, or rather the Clubhouse, incorporated, also in getting a charter." ——Premont, Texas.

All you have to do is write to G.S.O. to get a Group registered.

There is no charge—instead, we send each new Group a complimentary package of literature, its *World Directory*, etc. G.S.O. does not issue any charters.

As for getting a clubhouse incorporated, that is a separate legal matter which should be handled locally *outside* the Group, A.A. experience indicates. Write for more information.
