

GSO GATHERING 1962 DIRECTORY INFORMATION

This year there should be only one address on the return card. We will use this address for all our mailings and will list it that way in the 1962 Directory. Anita R. of GSO Staff, who is in charge of this operation, has asked that all cards be returned by January 1, 1962.

For those who may not know, each year GSO compiles a World Directory and distributes it to General Service Conference Committees, Central and Intergroup Offices, Groups, Loners and Internationalists, all over the world. The Directory is confidential, but individual members can purchase copies through their group officers.

GSO recently received the following order from the Secretary of a group at a New Jersey State Hospital:

A LETTER FROM PARIS

"Dear Ann: Thanks for your letter. It arrived shortly after my return here to Paris from seven weeks of A.A. in the U.S. I was in Los Angeles for eleven days with my sponsor, Anna L., and her husband. As it happened, my third A.A. birthday came while I was there and I got my cake at the Motion Picture Group's meeting in Hollywood. You might have thought I was the first fellow to make three years in this organization, and now I'm spoiled rotten! I went to eight meetings out there and met a lot of nice people, and will say the California A.A. is tremendous.

"Most of my time was spent in Oklahoma. I was in Tulsa for a few days and we had a sort of family meeting and program. Uncle Dud was the chairman, and my cousin Bill and I were the speakers - and they really gave me a ride. I think it was the first time I realized that anything I ever did while drinking was funny. It was a very serious matter to me and I've always been reticent to talk about it much. Anyway, they made it sound funny and the whole evening was fun.

"In keeping with Ab A.'s Birthday Plan idea, I will enclose a birthday contribution as a little token of my appreciation, both to A.A. and to Ab. Ab was my Uncle Dud's sponsor in Tulsa nearly fifteen years ago, and Uncle Dud is directly responsible for my joining.

"We had a good meeting here in Paris at the English-speaking group last night with several visitors and a new and promising candidate. A fellow called from the Orleans base this morning and wanted all the literature we could spare him, in a hurry. The doctors have given him permission to hold meetings in the base hospital. We'll help him all we can. Thanks again for everything. Sincerely, Fred S."

This month, Bert R. celebrates his tenth A.A. Birthday in Jasper, Alberta, with one other member. He moved to Jasper after joining A.A. and has been trying to get a group going there ever since. "Perhaps I made a mistake in starting out with an open meeting," Bert writes. "I knew some people who could really use the program and hoped a few might turn up out of curiosity. But nobody from Jasper appeared. We had a meeting though, with A.A.'s coming to give us a boost from other towns, some as much as two hundred miles away.

ANSWERING SERVICE IN DAYTON

Miles E., of Dayton, Ohio, writes, "After our years of difficulties with A.A.'s answering service, the Telephone Company's cooperation has helped us solve our problem. The company has installed three 'off-premise extension' phones in the homes of three A.A.'s who are Intergroup Committee members and who live in different parts of the city. These three phones all have the same number which is listed in the phone book under 'A.A. Information.' When this number is called, all three phones ring simultaneously. By prearrangement, someone is always on hand to take the call. Whoever answers the call checks his list of available 12th-Steppers and relays the call to an A.A. in the caller's part of town.

"This system has been in operation for a year and works fine. Maybe somebody else can use the idea. If you want more details, let us know."

SOME BASIC INFORMATION ABOUT A.A.

The pamphlet, "Background Information on the Fellowship of A.A.", is becoming increasingly popular with A.A. members. Prepared originally by GSO for release at A.A.'s 25th Anniversary in 1960, this little folder was designed to answer quickly questions about A.A. that are asked most frequently by writers, editors and broadcasters. "Who runs A.A.?", "How is A.A. supported?", "Does A.A. recruit?", "How is A.A. organized?" are some of the questions it asks and succinctly answers.

Many groups are now finding it useful in performing their public information service and individual members are using it to brief their friends and relatives in the basic facts of A.A. *This is now available in Spanish.*

ANONYMITY BREAK

The Directors of A.A. World Services, Inc., have granted permission to a certain area committee to reprint a limited number of copies of Bill W.'s article, "Why Alcoholics Anonymous is Anonymous." The reprint is a section from the pamphlet, "A.A. Tradition - How It Developed." Proper credit to the source has been shown on the reprint and no copies will be sold.

The secretaries of forty-three local groups have already received copies and there will now follow an extensive distribution to A.A. members in this area so that they may know the story behind our Tradition of Anonymity.

Most A.A.'s today are committed wholeheartedly to the principle of personal anonymity before the public. Identification of an A.A. member at press, radio, TV or film level is rare, but occasionally it does happen. Anonymity breaks usually occur when some overgenerous friend in one of the communications media, professionally disciplined to the use of names, gives one of our members public recognition when none is sought.

However, there have been some rare cases when individual members, for private reasons which seemed to them more important than A.A. Tradition, deliberately identified themselves publicly by name. This particular area committee had been faced with the latter situation. They believed that an informed membership would be the most effective means of preventing the occurrence of another "break." This was the reason they wanted the reprints. The A.A. World Services Directors were happy to cooperate.

A. A. FILM FOR RENT

"One Day At a Time," the popular Dupont television show on the founding of A.A., is now available for renting on 16 mm film. It was first shown on TV in November, 1955, and was rerun in March of 1957, throughout most of the U.S. Dupont made prints available to A.A. groups on a loan basis until the film rights were sold.

The film is now owned by Official Films, Inc., who have notified us that they will rent 16-mm prints to A.A. groups. The rental fee is \$25.00, plus shipping costs. This company will mail orders C.O.D. and asks that prints be returned, prepaid, within forty-eight hours. We understand this offer is also extended to groups in Canada and overseas. Showing is limited to non-paying audiences and the fee does not include TV or theatrical rights.
